Power is supplied by a rechargeable battery pack, Type 17-S1Z0-0020/****, that may be replaced in a non-hazardous location. Also provided for use in non-hazardous locations are a DC-in port and USB-C connector for charging and data transfer. To facilitate operation, the USB-C connector must be used with the BARTEC Type G7-A0Z0-0010 cable, which is provided as an accessory.
